RE-TENDER NOTICE 2020-2021 (COVER NO. 1)

It is hereby notified for the information of the general public that Cantonment Board, Dalhousie Cantt has decided to give on license the collection of Toll Tax, levied under 66 of Cantonments Act 2006, within the limits of the Dalhousie Cantonment (Toll tax barrier situated at Banikhet), in accordance with sanction granted by the Govt. of India, Ministry of Defence, New Delhi vide their Notification No. 1684 dated, 01-10-1949 as amended from time to time, for a period of one year commencing from 01-10-2020 to 30-09-2021 or from the date of approval of the Board.

Tender is invited through electronic tendering system for the collection of Toll Tax situated at Banikhet from interested parties/contractors who are technically and financially capable as per the terms and conditions given below.

- 2. Reserve price of the bid is **Rs. 73,50,786/-.**
- 3. All the financial bids will be subject to final approval by the Cantt Board only.
- 4. The tender/contract can be cancelled/terminated by the Board at any stage without giving any reason, what so ever.

The financial bid submitted must be a scanned copy of the **BOQ** document. The amount must be mentioned in numeric and words, clearly. All the details mentioned or documents attached, must be legible and clear. Ambiguous/unclear documents will not be accepted, and the bid is liable to be rejected.

TERMS AND CONDITIONS

- 1. The Tender documents can be downloaded from the website https://cbdalhousie.org.in/ and https://eprocure.gov.in/eprocure/app. All the critical dates regarding the tender have been given in one of the sections below
- 2. The Tender fee of **Rs.2,500/-** (not refundable) must be deposited as per the details are given below:

The statement of transaction must be attached along with other Technical Bid documents.

- 3. Receipt of EMD or copy of FDR of **Rs. 5,00,000/-** must be attached along with other Technical Bid documents. The EMD must be deposit in the office in the shape of FDR.
- 4. The successful bidder will have to deposit **25**% of the highest bid as security, in advance, in the form of FDR from any Nationalized Bank in favor of Chief Executive Officer, Dalhousie Cantt, immediately after acceptance of the bid. This security will be released to the bidder after one month on the completion of the contract period. The Cantonment Board, Dalhousie Cantt, reserves the right to accept or reject any bid at any time without assigning any reason or written notice.
- 5. The successful Bidder will have to abide by all the provisions of the Cantonments Act, 2006 or any other instructions of the Govt. of India or Chief Executive Officer.
- 6. The Chief Executive Officer or any person authorized by him may inspect the Toll Post at any time.
- 7. The successful bidder will execute an agreement with the Cantonment Board, Dalhousie Cantt, on non-judicial stamp paper of Rs 50/- within 7 days of the acceptance letter and before taking over the charge of the Toll Post, failing which earnest money **Rs 5,00,000/-** deposited by him will be forfeited by the Board.
- 8. The amount offered by the successful bidder will be deposited in advance in 04 equal quarterly installments on or before 10th of first month of the quarter i.e. **01-10-2020. 10-01-2021, 10-04-2021 and 10-07-2021,** failing which, **18%** penal interest will be charged. In the event of non-payment of quarterly installment by the end of the month, the contract is liable to be terminated immediately without any notice at the risk and cost of the successful bidder apart from forfeiture of security and blacklisting of the contractor. The installment will be received of full amount. No part payment of quarterly installment will be accepted.
- 9. All Toll Tax receipt books will be got printed by the successful bidder at his

own expense & will be open to scrutiny to the CEO or any person duly authorized by him. The contractor may maintain the record through electronic collection medium also.

- 10. Although the Toll Post will be given on license for a period of one year yet in case of any administrative difficulty for any delay in handing over the Toll Post by the Cantonment Board bid amount will be adjusted proportionately on average basis of each day.
- 11. The premises of the Toll Post shall not be used for any other purpose except for the recovery of the Toll Tax. No unwanted person will be allowed to sit/stay at the Toll Tax Barrier.
- 12. The licensee shall engage educated and well-behaved staff with proper uniform showing due courtesy and respect to the public, for running Toll Tax Post. The complete bio –data of the staff working in the Toll Post will be provided by the license to the Cantonment Board. All pay & allowances of the staff engaged by the license will be borne by him only. The character and other antecedents of the staff of Toll Tax will be got verified from the Police by the licensee.
- 13. The licensee will be responsible to implement all Labour laws i.e. by the Minimum Wages Act, Labour Act, payment of Compensation Act or any other Act in force for this purpose.
- 14. The licensee will be solely responsible for any illegal and anti-social activities in the premises. The license will be liable to pay the compensation for any damage to the premises.
- 15. The successful bidder shall be responsible for adopting all precautionary measures with due care and safety, at the time of stopping the vehicle for the payment of Toll Tax.
- 16. Conditional bids shall be summarily rejected.
- 17. The Toll Tax post will remain open round the clock.
- 18. On the expiry of the contract period or in case of termination of license period, the licensee shall hand over the possession of the vacant premises peacefully to the Cantonment Board.
- 19. The Cantonment Board shall not be responsible for any loss/disruption sustained by the contractor due to strike, natural calamities or due to any other reason.
- 20. No subletting will be permitted.
- 21. Toll Tax is not levied on Union/State Government vehicles, Army vehicles,

Cantonment Board vehicles, Municipal Committee vehicles or any other category specified by Govt. order.

- 22. The contractor will be liable to pay the charges of electricity and telephone bills etc.
- 23. The Contractor will pay the minimum wages to the workers as approved by the Central Government/Himachal Pradesh Government.
- 24. The Toll Tax will be levied on the vehicles coming from Nainikhad side only.
- 25. It will be the responsibility of the license to obtain Cantt 15M/46S receipt from Tax clerk of Cantonment Board, after depositing the amount online in Dalhousie Cantt Fund failing which Cantonment Board will not be responsible for any lapse/loss.
- 26. If the License fails to collect the Toll due to one reason or the other, the Cantonment Board will not be responsible for any loss etc.
- 27. In case the recovery of any amount remains in balance from the licensee, it will be recovered from him under section 324 of the Cantonments Act 2006.
- 28. The Cantonment Board will be competent to modify or add any condition in the Agreement.
- 29. The official reserve bid will Rs. **73,50,786/-** any bid less then this amount will not be considered/accepted.
- 30. All the bidders are required to clear their dues, if any, of taxes payable to Cantonment Board.
- 31. The vehicles going for filling of petrol/ diesel to petrol pump near Toll Tax Barrier will not be liable to pay the Toll Tax.
- 32. The Toll Tax rates are as follows:-

02	Taxies, NC, pic up etc	Rs. 25/- per vehicle
03	Tampo traveler/ Mini bus	Rs. 35/- per vehicle
04	Bus, truck etc	Rs. 50/- per vehicle
05	Big trolly etc	Rs. 60/- per vehicle
06	Pvt car, jeep, Qualies etc (annual pass)	Rs. 375/- per vehicle

- * Subject to change by the Cantonment Board, Dalhousie Cantonment at any time as per rules.
- 33. In case of any dispute relating to any terms and conditions or other matter relating to the Toll Tax or its collection, the matter will be referred to the President Cantonment Board, Dalhousie Cantt, for arbitration whose decision will be final and binding on all parties.
- 34. Any bid once offered cannot be cancelled or amended in any manner by the bidders. In such case earnest money of Rs. **5,00,000**/- will be forfeited by the Cantonment Board.
- 35. If the amount of the bid found equal for two or more bidders, the bids will be called again.
- 36. The Contractor should ensure that all his employees deputed on the toll tax in proper uniform. It is the responsibility of the Contractor to provide them uniform etc.
- 37. No manual bids will be accepted. All bids must be submitted online using http://eprocure.gov.in/eprocure/app website.
- 38. The Cantonment Board reserves the right to change the terms and conditions at any time. The same will be updated on the above mentioned websites.
- 39. If the Board revised the rates of present toll taxes during the contract period, the highest bidder will have to deposit the extra amount plus highest bid on revised rates as decided by the Board for remaining period of contract.
