9. TENDER FOR LAYING OF ROADS, DRAINS ETC. FOR THE YEAR 2022-2023 :

Reference Tender for Laying of Roads, drains etc. for the year 2022-2023 floated by this office on Gem Portal :

The Cantonment Board Dalhousie floated a tender for laying of roads, drains etc., for the year 2022-2023 on https://eprocure.gov.in/eprocure/app Portal ON 31.03.2022. During the first attempt, no tenders were received. Hence, second attempt was made by refloating the tender on 25.04.2022. In the second attempt only one bid was received. However, since all the mandatory documents were not submitted by the tenderer, the bid was cancelled, and tender floated again for the third time on 04.05.2022. During the third time also only one bid was received,. The technical and financial bids were opened after following due procedure and constitution of Committees for the purpose as required vide GeM. The rate quoted was 38% above MES SSR 2020 rates. The tender rate was very high and would result in loss to the Cantonment Board. Hence, it was decided to retender for the fourth time. In the fourth attempt also one tender was received at the same rate of 38% above MES SSR 2020 rates of 2020.

Since the rate is extraordinarily high, it is suggested that the Board may decide to undertake the work departmentally by hiring equipment and labour wherever necessary. Meanwhile, the Contractor was also called for negotiations and he has offered to undertake the work at rate of 15% above SSR. The matter is placed before the Board for a decision.

Ref CBR No.76 dated 09.12.2015

The Board may consider & approve the request letter dated 25-05-2022 of The Supdt. of Post Offices, Chamba requesting to extend the lease period of said Cantt Fund property to the Postal Department for running of Sub Post office at Dalhousie Cantt for a further period of 03 years w.e.f 01-06-2022 to 31-05-2025.

The Board may extend the period of lease by 3 years on yearly increase of rent at 15%.

OFFICE NOTE:

The above CF building was leased out for the period of 05 years w.e.f 01-06-2017 to 31-05-2022 on payment of Rs. 35,000/- p.a. It is recommended that 15% yearly increase on the last rent being Govt. organization may be considered. The Postal Department has requested to maintain the same rent, which is not feasible.

The Total Salary payable to Asst.HM (Outsourced) would be Rs.455/- per day (as per HP Govt rates) plus Rs.2000/- incentive extra.
