2. Interested bidders may inspect vehicles on any working day at Cantonment Board Dalhousie Cantt on any day in between 22-11-2022 to 11-12-2022.
3. The Cantonment Board shall not guarantee quality of the vehicle put

under auction in any way. It shall be the responsibility of the bidders to inspect and understand the quality of the vehicle and satisfy themselves about the condition of the vehicle before participating in the auction proceedings.

4. The offers submitted would be governed by all the terms and conditions laid down in the present auction notice. There would be no post auction negotiation. The Acceptance Format duly printed the letter head of the interested bidders' firm should be deposited along with online transaction receipt of EMD as mentioned above.

5. A bidder must have a registered firm with a valid GST registration No. PAN, Aadhar/Address Proof, Bank Account details etc. As the bidding is online on Government-e Marketplace (GeM) portal, bidders shall comply terms and conditions laid down by the Gem authorities and procure registration number etc from the GeM authorities before the participation in the bidding.

6. Any other information can be obtained from office of the Cantonment Board Dalhousie Cantt HP on any working day through Mob No. 01899240603, 9419926373, 9418417701, 9418060712 9459233151 9418038742 up to the last date of submission of bids.

7. Incomplete bids not conforming strictly in the manner prescribed/offer as well as conditional Auction shall not be considered and shall be summarily rejected.

8. The bid security money would be refundable to un-successful bidder on finalization of the auction and shall carry no interest.

9. Auction would commence at Reserve Price value. Prospective bidders shall improve their offers only in multiple of Rs. 1000/ (Rupees one thousand only) during the subsequent rounds.

10. Competent authority reserves the right to accept or reject any or all auction bids without assigning any reason/notice whatsoever and are not bound to accept the highest auction rates. The competent authority also reserves the right to cancel the auction at any stage without assigning any reason and competent authority will not be liable for any costs and consequences incurred

by the intending bidder.

11. The successful bidder would be allowed to remove the vehicle(s) from the premises after making full payment and completion all procedural formalities.

12. The successful bidder should lift/taken away auctioned vehicle(s) within five (7) days at his own cost on "as is where" is basis after paying total Sale Value along with GST @ 18% or at the prevailing rates as per Government norms from time to time, failing which the bid security money shall be forfeited and pecuniary loss, if any, shall be recovered from them.

13. The bid security money of successful bidder shall be returned after completion of process including the cleaning the site completely including the removal of scrap etc and shall carry no interest on it.

14. All disputes in this regard are subject to jurisdiction of Hon'ble Courts located at Dalhousie only.
