
**Agenda No.02: IMPLEMENTATION OF GOVERNMENT'S DECISION  
ON THE RECOMMENDATION OF THE SEVENTH  
CENTRAL PAY COMMISSION : REVISION OF  
PENSION OF THE PRE-2016 PENSIONERS/FAMILY  
PENSION ETC.**

To consider the Govt of India, Ministry of Defence, DGDE letter No.138/740/ADM/DE/17(PENSION) dated 16<sup>th</sup> May, 2017 along with Department of Pension & Pensioner's Welfare OMs F.NO.38/37/2016-P&PW(ii) dated 4<sup>th</sup> August, 2016 and No.38/37/2016-P&PW(A) dated 12<sup>th</sup> May, 2017 vide which the pension/family pensioners who were drawing pension/family pension before 01.01.2016 under the Central Civil Services Pension Rules, 1972.

The Cantonment Fund pensioners are eligible as per Rule 31 of the Cantt Fund Servant Rules, 1937 and Rule 33 and 34 of Cantonment Board Employees Service Rules-2021, the provisions of the CCS(Pension) Rules,1972 as amended from time to time mutatis mutandis govern the grant of Pension etc. The Govt has revised pension/family pension of the Cantonment Board employees are regulated w.e.f. 01/01/2016 with the condition that the revised pension/family pension so arrived at will be subject to a minimum of Rs.9000/- per month.
