AGENDA NO. 06: TRANSFER OF 98 PENSIONERS OF KHASYOL CANTONMENT TO CANTT BOARD, DALHOUSIE OR BAKLOH:

Reference PDDE WC Chandigarh letter No.1004/4/Gram Panchayat/DE/RMS-31665/56 dated 19.01.2023 regarding excision of civil areas from the limits of Khasyol Cantonment.

To read, consider and comply with the directions issued by the PDDE WC Chandigarh to the CEO Dalhousie vide the above letter to comply with the directions issued by Government of Defence, Ministry of Defence , Sena Bhawan, New Delhi vide para (iii) of letter No.19(101)/2010-D(Q&C) dated 19.01.2023 regarding transfer of 98 existing pensioners of Cantonment Board Khas Yol to Cantonment Board, Dalhousie OR Bakloh .

The 98 pensioners of Khasyol would be served by Cantonment Board, Dalhousie or Bakloh and the DGDE would provide additional Grant-in-aid to the concerned Board for serving these pensioners.

The matter is placed before the Cantonment Board for a decision. Relevant papers are placed on table.

RESOLUTION No.6: Considered and approved the transfer of 98 pensioners of Khas Yol Cantt and they will be served by Dalhousie Cantonment Board. The PCB stated that since the Cantonment Board Dalhousie is a deficit Cantonment already dependent heavily on Grants-in-aid, the DGDE is requested for timely release of additional grant specially for the 98 pensioners transferred from Khasyol to Dalhousie Cantonment. Only on receipt of additional grant, the Cantonment Board Dalhousie would be able to provide service to the 98 pensioners.

AGENDA No. 07: EXTENSION OF CONTRACT PERIOD OF TOLL TAX BARRIER SITUATED AT BANIKHET:

Reference PDDE WC letter No.30/Taxes-Non Taxes/Cantt/DE/WC/Vol-II/RMS-3116 dated 14.6.2022 forwarding DGDE letter No.53/50/Gen/VET & No.VET/C/DE/2022 dated 14.06.2022.

The Board may note that as per the directions of DGDE/PDDE WC received vide the above letters, this Board has submitted proposal for discontinuation of Toll Tax. However until receipt of Gazette Notification for discontinuation of toll Tax, the Board had considered extension of the present contract. The present contract has already been extended twice.

The Board vide CBR No, 4 dated 20.7.2022 had resolved to extend the Toll Tax contract upto 16.1.2023 or till receipt of Gazette Notification, whichever is earlier. However, since the Gazette Notification has not yet been received and to avoid financial loss to the Board, the Board may consider extension of the present Toll tax contract, on the old terms & conditions of the agreement, upto 31.03.2023 or till receipt of the Gazette Notification, whichever is earlier.

Relevant papers are placed on table.

OFFICE NOTE

This Board has already extended the present Toll Tax contract twice by 03 monthly periods, first w.e.f 17-07-2022 to 16-10-2022 vide CBR No. 4 dated 20.07.2022 and again upto 16-01-2023 vide CBR No. 02 dated 05.12.2022. Directions were already issued by the DG DE New Delhi Cantt letter No. 53/50/Gen/VET and VEF/C/DE /2022 dated 26-08-2022 along with letter No. 53/50/Gen/VET and VEF/C/DE/2022 dated 30-08-2022 to forward proposals for discontinuation of Toll Tax collection. The proposal to the above effect has already been forwarded to higher authority for publication of Gazette Notification as the discontinuance would be required to be done by publication of Gazette Notification. Till such time the Gazette Notification for discontinuation is received, the Board may consider extension of the existing Toll Tax contract to avoid financial loss to the Board.

Hence, the Board may consider extending the period of Toll Tax contract upto 31-03-2023 or till receipt of Gazette Notification whichever is earlier. The current extended period expired on 16-01-2023.

Office Note:

The property bearing Sy.No.88/57 admeasuring 284.750 was initially granted as an indefinite lease on 21.5.1919 in Cantt Code 1912 Form 'B' to Shri Saligram Khanna S/o Shri Damodar Dass for construction of building at a lease rent of Re.1/- per annum. The property was later transferred in the name of Shri Dyan Chand Khanna through inheritance.

Similarly, the property bearing Sy.No.88/58 admeasuring 2428.00 sq.ft was initially granted as indefinite or perpetual lease on 23.11.1918 to Shri Dewki Chand Khanna S/o Shri Lalla Damodar Dass for construction of building at a lease rent of Rs.6.50 per annum . The property was later transferred in the name of Shri Dyan Chand Khanna through inheritance.

On 26.04.1967, Shri Dhyan Chand Khanna has sold both the above properties bearing Sy.No.88/57 and 88/58 through sale deed for Rs.7,000/- in the name of Sardar Isher Singh and his brothers Bhagat Singh, Tarlok Singh, Hari Singh and Mohinder Singh, sons of (late) Sardar Ram Singh. The properties bearing Sy.No.88/57 & 88/58 were mutated in the name of Shri Ishar Singh and brothers vide CBR No.50 dated 15.07.1967.

However, it is observed that the entry in GLR has been made in the name of Sardar Isher Singh and brothers perhaps for convenience sake, and the individual names of the brothers as per sale deed has not been mentioned in the GLR.

Sardar Isher Singh expired on 28.12.2012. His 4 legal heirs have applied for transfer of his share of property in their names. However, if the names of the legal heir are incorporated, the term 'and brothers' would also have to be replaced with the names of the brothers. Hence, all the names have been mentioned as transferees.

One objection was received from Shri Gurvinder Singh, Dalhousie, to the public notice stating that Sardar Isher Singh is not the son of Ram Singh. However, since the property is not inherited by Sardar Isher Singh from his father, the objection has no binding on property purchased by Sardar Isher Singh and co-purchasers.

There is no unauthorized construction or encroachment on the site/adjoining Govt land in the above case as per the report of the Cantt Engineer. Hence, the mutation is placed before the Board for sanction.

The Solid Waste Management Bye-Laws of Dalhousie Cantonment were published in public domain for inviting objections and suggestions as per the instructions of PDDE, WC issued vide letter No. 2 / बायलास / एसडब्ल्यूएम / रस / पक / आरएमएस 30450/32 dated 03.08.2022 & DG DE Delhi Cantt letter No. 76/38/Rules/ MSW Rules/C/DE/17/Vol-II dated 01.08.2022, to refer bye-laws of Delhi Cantonment Board and suitably amend their draft bye-laws of Solid Waste Management especially with regard to the language and terminology as per instructions laid down under relevant chapter - notification of administrative instructions Cantonment Laws Vol-II by Sh. J.P. Mittal and put the same in public domain for inviting objections and suggestions as per the instructions.

Accordingly, objections and suggestions were invited by Cantt Board Dalhousie from the general public vide Public Notice No. CBD/13/1/PCB/2022-23 dated 21st September, 2022, within 15 days from issue of public notice.

Since no objections/suggestions have been received from the public within stipulated period, the Bye Laws as amended in English and Hindi is to be forwarded to the Directorate, Defence Estates, Western Command for onward submission to DGDE, New Delhi for gazette publication, after approval by the Cantonment Board.
