AGENDA No. 02: GRANT OF ADDITIONAL INCREMENT TO DRIVER ON COMPLETION OF 15, 20 AND 25 YEARS OF SERVICE:

To consider the Government of Himachal Pradesh Finance (Regulations) Department letter No. Fin(C)-A(9)-7/98 dated 13th October, 2022, whereby Drivers who have completed 15, 20 and 25 years of regular service shall be allowed one increment each on completion of said years of service, w.e.f. 01.10.2022.

Shri Sorma Ram, Driver, Cantonment Board, Dalhousie was promoted as Driver on 25.04.2000 and he has completed 15 years of service on 25-04-2015 and 20 years Service on 25-04-2020. Shri Sorma Ram, Driver is entitled to the benefit of one increment each for completion of 15 Years and 20 Years regular service respectively.


OFFICE NOTE :

AGENDA NO. 3 : STANDARDIZATION OF FEES FOR TRANSFER OF NAME IN THE PROPERTY TAX REGISTER :

Reference CBR No. 02 dated 7-9-2022.

To reconsider the matter with regard to levy of following fees by the Cantonment Board vide its Resolution referred to above. The Board may consolidate the following fees in one property number instead of each property sub-assessment numbers.

<u>Sr. No.</u>	<u>Nature of fee</u>	<u>Approved fee</u>
1.	Charges of public notice publication	As per DAVP rate in newspaper (Rs. 3000/-)

At present, the paper publication charges are being charged for each sub number of a property though only one paper publication is done for one property and its sub numbers.

OFFICE NOTE :


DGDE MOD Delhi Cantt vide their letter No.76/6/Chhawani (OBPAS)/C/DE 2021 Vol III FMS 70452 dated 31-08-2022 received under Dte of DE WC letter No. 927/OMCB/CB/DE/WC/ 2022/17/3160 dated 06-09-2022 directing therein to impose fee for transfer of name in the Property Tax register of Cantonment Board.

The matter was considered and the Board approved by circulation the proposed fees as mentioned above in agenda vide CBR No. 02 dated 07-09-2022. In view of the above the levy of rate of public publication for properties be consolidated in one main property number in place of each sub property/Assessment Numbers. Therefore matter is again placed before the Board for reconsideration.
