**GENERAL TERMS AND CONDITIONS OF CONTRACT**

1. Contractor registered with any Cantt Board, any state PWD, C.P.W.D., M.E.S, IPH, Railway whose tendering limit for single tender is 25 lakhs and above can apply for e-tender. However the condition of 25 lakhs will not be applicable on the contractors enlisted in the Cantt Boards/MSME/NSIC/Start up India.
2. Cost of tender fees is Rs.2000/- (Non refundable) must be deposited through echhawani module i.e echhawani.gov.in/citizen only.  
**\* Receipt shall be uploaded online.**
3. Cost of Tender Fee shall be non-refundable.
4. Please note that Cover No. 2 (Financial bid) will be opened only in respect of qualified and eligible contractors who fulfill the eligibility/criteria according to Cover No. 1 (Technical Bid).
5. Scanned copy of receipt of online tender fee deposit is nonrefundable.
6. Scanned copy of FDR on account of Earnest Money Deposit (EMD) and Security (to be pledged to CEO Cantonment Board Dalhousie) as per **Annexure-“B”**.
7. Persons/Individuals/Firms having litigation of any kind in any court against Cantt Board Dalhousie/Bakloh will not be allowed to participate in the tender.
8. Contractor should quote his rates at the percentage above or below of the MES Schedule of Rates 2020 amended up to date. The total tender amount will be split up in small work orders. The Cantt Board will be free to call any other tender within the budget amount separately; the contractor shall have no claim for that.
9. The tenders are subject to the approval of the Cantonment Board, Dalhousie who does not bind themselves to accept the lowest tender or to give reasons for rejecting any/all tenders.
10. The contractor will be required to deposit security equivalent to 5% of the estimated amount of work within 07 days after receipt of acceptance letter in the shape of Payee Demand Draft, Fixed Deposit Receipt from a commercial bank (pledged to the Chief Executive Officer, Dalhousie Cantt) or online deposit. This security deposit will be refunded to the contractor on receipt of an application from him after one year from the date of completion of contract (including extension if granted) of the contract against which the security has been deposited and after a report by the Cantt Engineer about the satisfactory work. If the contractor fails to deposit the security, the earnest money deposited by him will be forfeited and his tender will be cancelled and may be allotted to the second lowest with the approval of the Board.

11. The successful contractor will have to execute an Agreement on Non-Judicial stamp paper of appropriate value within 07 days of acceptance of tender failing which the tender may be offered to the next lowest Tenderer.
12. The Cantonment Board, Dalhousie, shall supply no material of any description viz. cement, steel, etc. However if the Board deems fit, it may supply any material of its requirement to the Contractor. For that payment for fixing will be made to the contractor.
13. If the contractor fails to complete the work within the specified period given in the work order or within the period of extension if any granted to him on his request a penalty equal to 1% of the estimated left out work for every week will be charged till the work is completed. The left out estimate prepared by the office of the Cantonment Board will be final and binding on the contractor.
14. If, the contractor fails to execute any work entrusted to him within prescribed time, the Chief Executive Officer will be at liberty to get the work executed through any other Agency/Departmentally at risk and cost of the contractor and recover the excess expenditure from security of the contractor and if the security falls short the contractor will pay the difference or may be recovered from amount of bill pending to the contractor.
15. Conditional tender will not be accepted.
16. The Contractor is required to pay water charges @ Rs.3.75/- per every Rs.1000/- and electricity Rs 10/- per thousand worth of work done. Based on presentation of the bill or may be deducted from the bill of the Contractor. Space/store, if available may be provided on the prevalent market rate/rent. The decision of the CEO for assessment of rent in this behalf will be final. The contractor shall vacate the space/store allotted for execution of work on the expiry of terms of his contract including any extension given. The store/space will have to be vacated within 30 days from the expiry of contract. If the contractor fails to vacate the store/space, he will be debarred from participating tender till the space is vacated and a penalty equal to Rs. 500/- per day will be levied till the vacation of site in addition to the fixed rent.
17. Income tax /GST or any tax imposed during the contract period etc will be deducted from the bill of the contractor as per Govt. Rules.
18. The Cantonment Board reserves all the rights to accept or reject any or all tenders without assigning any reason.
19. A tenderer shall be deemed to have read and have full knowledge of all relevant documents, working condition and such other conditions, which effect entire work. The Cantonment Board don't bind themselves to accept the lowest tender or to give any explanation for not accepting the lowest tender.
20. Any original application/technical bid (Cover 1) received without any of the enclosures mentioned in checklist and after the due date and time will be rejected.
21. The CEO/Cantt. Board reserve the right to accept or reject any application if found to be lacking in any of the prescribed requirements.
22. No manual bid will be accepted.

23. The contractor shall be required to undertake the work immediately as soon as the work order is placed to the firm. Contractor may be directed to do some original work within this contract and contractor shall have no objection what so ever, to execution of such work.
24. This Tender Notice will form part of the Contract Agreement. However while executing the agreement, conditions in addition to these may be imposed or any modification may be done.
25. That the Contractor shall work strictly in accordance with the specifications, plans, design, drawings and instructions issued to him from time to time by the office of the Cantonment Board. In case of any default/defect on the part of the Contractor, he shall be liable to re-build/remove the same without claiming any further cost what-so-ever incurred thereon and shall do so within the time allowed by the Chief Executive Officer, Contractor shall be bound to make good the damaged portion without any further charges to the Board.
26. The Chief Executive Officer will make running payment to the Contractor. Duration of payment and number of payments to be made to contractor is as per the discretion of CEO. Running payment will be made up to 90% work done or 75% of material cost lying at site/store.
27. CEO will be competent to extend the period of contract upto three months and Board will be competent to extend beyond three months. After the expiry of contract or till the finalization of new contract, Any important work if required may be executed through this contractor on the same rates even after expiry of contract with consent of Contractor. However decision of the CEO will be final.
28. That if the Contractor or any of his workmen or servants break, deface, injure, destroy and part of the building or any Cantt. Fund or Private property, in which they may be working or any building or premises where the work or any part of it is being executed or if damage happens or imperfection becomes apparent in it within one year after its completion, he shall make the same good at his own expenses or in default, the CEO may cause the same make good and deduct the expenses from any sum(s) that may become due to the Contractor or from the security or otherwise as land revenue.
29. During the work, if any injury or fatal loss occurs the contractor will be liable for that as per the existing rules and instructions.
30. That the Contractor shall execute the works, as ordered under the Supervision of the Cantt. Engineer/CEO or Cantonment Board, Dalhousie Cantt. The Cantonment engineer will be In-charge of the work(s) and shall be responsible for getting the works done strictly in accordance with the specification designs and required standard material and measurement and has hereinafter signed this Agreement as witness. The Cantt. Engineer is hereinafter called the "Official In charge of Works".
31. The materials used by the Contractor should be as per the list of firms attached with this tender document, if not available in the market then as per the directions of the EIC
32. The Chief Executive Officer will be competent to make the payment of any bill of the contractor up to 20 % more than the estimated cost. But if the variation in the work exceeds more than 20%, revised sanction will have to be obtained from the Board.
33. That it will be the responsibility of the Contractor to pay the wages as also the compensation of any other damages/liability, which may occur by any cause what-so-ever to the workers employed by him.

34. That the Contractor shall keep on his employment a trained Engineer for supervision of the work(s).
35. That the Contractor shall produce the documentary evidence/receipts/ vouchers to the CEO if he decides to check them relating to purchases of material/stores or wages bill(s) for the workers/Engineers employed by him.
36. That in no case contractor shall claim or charge the enhanced rate because of inflationary pressure on the market during the period of contract. All disputes will be settled by the Cantt Board and board will be final authority in case of any dispute.
37. The MES SSR is guiding principal to the Cantonment Board and it does not bind the EIC to lay down its own conditions to get better work results. In case of situation/circumstances demands variation in the specification or material may be made within the sanctioned estimate.
38. If the department desires to get execute any work or part of the work departmentally, the contractor shall not have any claim/objection for that. Department may call separate tender for any specific job.
39. If any material is not available in the SSR, star rates may be prepared and CEO will approve the star rates.
40. The contractor will be liable to pay GST as per Govt orders.
41. Cantt Board may conduct third party inspection for quality check and payment may be made after third party inspection.
42. The tenderer will have to submit work done certificate of last three years. He will be considered qualified if the total work done of three years exceeds Rs 20 lakhs.
43. Any contractor /firm who has approached a court of law against the Cantonment Board will not be considered eligible for participating in the tender till the final decision of the court.
44. The conditions stipulated in DGDE letter No. 109/PV-DATA/VIG/DE/447 dated 27.06.2024 will form part of this tendering conditions and will be binding on the tenderer.

45. **MODE OF SUBMISSION OF TENDER**

The tenderer has to submit online bids viz. Technical bid (Cover 1) and financial bid (Cover 2). The technical bid (Cover 1) must be accompanied with the following documents:-

- I. **Technical bid, upload the following documents in the technical bid (Cover-1)**
- a) Scanned copy of Permanent Account Number (PAN) Card.
- b) Scanned copy of Registration Certificate from any CANTT BOARD/MES/CPWD/any state PWD and Railway of the appropriate class / Category/ MSME/NSIC/Start up India.

## **46. OPENING OF TENDER**

**I. Technical bid (Cover 1):** Technical bids will be opened in the Office of the Cantonment Board, Dalhousie by the Technical Evaluation Committee in the presence of Chief Executive Officer/tender committee (Bid openers). Any or all present participants or their agent may be present at the time of opening of tender; even if any participant or their agent is absent, the bid will be opened at stipulated time. Technical bid will be opened online first to verify its contents as per requirement. If the various documents contained do not meet the requirements of the Cantonment Board Dalhousie Cantt, the contractor's financial bid will not be considered for further action.

**II. Financial bid (Cover 2):** This shall be opened after only if contents of Technical bid (Cover 1) uploaded online as per checklist are found acceptable to the Cantonment Board/CEO, Dalhousie and original are submitted offline in the office of Cantonment Board Dalhousie as per due dates. Financial bid of only those tenderers who qualified in the technical bid (Cover 1). If the financial bid i.e. BOQ could not be opened due to "Any Technical Reason" and if minimum three financial bids i.e. BOQ opened successfully then the tender will succeed for further action. The failed bid/bids shall be considered to be rejected.

Cantonment Board, Dalhousie is not responsible for any delay due to link failure/internet problem etc. in respect of submission/receipt of any documents or in submission of e-bid. The Board may accept the tender even, if less than three tenders are received. Provided effective completion is not lacking.

47. Technical bid and financial/price bid will be submitted concurrently, duly digitally signed in the website portal <https://defproc.gov.in/nicgep/app> . The tender document may be

downloaded from website & submission of technical bid / financial bid as per Tender time schedule.

48. Tenders are to be submitted online through the website stated above. All the documents uploaded by the Tender inviting Authority form an integral part of contract. Tenderers are required to upload all the tender documents along with the other documents, as asked for in the tender, through the above website within stipulated date and time as given in the Tender Notice.

49. The tenderer shall carefully go through the documents and prepare the required documents, and upload the scanned documents in Portable Document Format (PDF) to the portal in the designated location of Technical Bid. He needs to fill up the rates, downloaded for the work in the designated cell and upload the same in designated location of financial bid.

50. The documents uploaded must be virus scanned and digitally signed using the Digital Signature Certificate (DSC) by the authorized signatory.

51. For submission of e-tender, bidders are requested to get themselves registered with <https://defproc.gov.in/nicgep/app> website along with class-II/III Digital Signature Certificate (DSC) issued by authorized issuing authority under IT Act 2003.

52. For complete details, refer website <https://defproc.gov.in/nicgep/app> at Defence eProcurement portal.

53. The department may issue amendment / errata to the tender documents before last date of submission of tender. The tenderers are required to read the tender documents in conjunction with amendments, if any, issued by the department the tenderer is not supposed to incorporate any amendment / errata in the body of tender documents either in ink or pencil. In case the tenderer on the body of tender incorporates amendments/errata issued, they shall not be considered and the amendment / errata issued by the department shall only hold good. The amendments/errata issued to these documents if any would be uploaded on web site of <https://defproc.gov.in/nicgep/app> and will also be uploaded on Cantonment Board web site <https://dalhousie.cantt.gov.in/tender/> the contractors shall visit these sites from time to time to see these amendments/errata.

54. The bidders are required to upload the completed documents only after satisfying each and every condition laid down in the tender documents.

55. Cantonment Board Dalhousie / CEO reserve the right to postpone and / or extend the date of receipt of opening of tenders or to withdraw the tender notice, without assigning any reason thereof. In such cases, the bidders shall not be entitled to any form of compensation from the Cantonment Board.

#### **SPECIAL INSTRUCTIONS TO THE CONTRACTORS/BIDDERS FOR THE E-SUBMISSION OF THE BIDS ONLINE THROUGH THIS EPROCUREMENT PORTAL**

1. Bidder should do Online Enrolment in the Portal using the option Click Here to Enroll available in the Home Page. Then the Digital Signature enrollment has to be done with the e-token, after logging into the portal. The e-token may be obtained from one of the authorized Certifying Authorities such as eMudhraCA/GNFC/IDRBT/Mtnl Trustline /SafeScript/TCS.

2. Bidder then logs into the portal giving user id / password chosen during enrollment.
3. The e-token that is registered should be used by the bidder and should not be misused by others.
4. DSC once mapped to an account cannot be remapped to any other account. It can only be inactivated.
5. The Bidders can update well in advance, the documents such as certificates, purchase order details etc., under my documents option and these can be selected as per tender requirements and then attached along with bid documents during bid submission. This will ensure lesser upload of bid documents.
6. After downloading / getting the tender schedules, the Bidder should go through them carefully and then submit the documents as per the tender document, otherwise, the bid will be rejected.
7. The BOQ template must not be modified/replaced by the bidder and the same should be uploaded after filling the relevant columns, else the bidder is liable to be rejected for that tender. Bidders are allowed to enter the Bidder Name and Values only.
8. If there are any clarifications, this may be obtained online through the e-Procurement Portal, or through the contact details given in the tender document. Bidder should take into account of the corrigendum published before submitting the bids online on the portal or on <https://defproc.gov.in/nicgep/app/> or <https://dalhousie.cantt.gov.in/tender/>
9. Bidder, in advance, should prepare the bid documents to be submitted as indicated in the tender schedule and they should be in PDF formats.
10. Bidder should arrange for the EMD and tender fee as specified in the tender. The original should be posted/couriered/given in person to the Tender Inviting Authority, within the bid submission date and time for the tender.
11. The bidder should read the terms and conditions and accepts the same to proceed further to submit the bids.
12. The bidder has to submit the tender document(s) online well in advance before the prescribed time to avoid any delay or problem during the bid submission process.
13. There is no limit on the size of the file uploaded at the server end. However, the upload is decided on the Memory available at the Client System as well as the Network bandwidth available at the client side at that point of time. In order to reduce the file size, bidders are suggested to scan the documents in 75-100 DPI so that the clarity is maintained and also the size of file also gets reduced. This will help in quick uploading even at very low bandwidth speeds.
14. It is important to note that, the bidder has to Click on the Freeze Bid Button, to ensure that he/she completes the Bid Submission Process. Bids, which are not Frozen, are considered as Incomplete/Invalid bids and are not considered for evaluation purposes.
15. Without Earnest Money tender will not be considered. Copy shall be uploaded online and original to be submitted on demand. **Annexure-“B”**.
16. The **Tender Inviting Authority (TIA)** will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders due to local issues.
17. The bidder may submit the bid documents online mode only, through this portal.

18. documents will not be handled through this system.
19. At the time of freezing the bid, the e-Procurement system will give a successful bid updation message after uploading all the bid documents submitted and then a bid summary will be shown with the bid no, date & time of submission of the bid with all other relevant details. The documents submitted by the bidders will be digitally signed using the e-token of the bidder and then submitted.
20. After the bid submission, the bid summary has to be printed and kept as an acknowledgement as a token of the submission of the bid. The bid summary will act as a proof of bid submission for a tender floated and will also act as an entry point to participate in the bid opening event
21. Successful bid submission from the system means, the bids as uploaded by the bidder is received and stored in the system. System does not certify for its correctness.
22. The bidder should see that the bid documents submitted should be, legible and free from virus and if the documents could not be opened, due to virus, during tender opening, the bid is liable to be rejected.
23. The time that is displayed from the server clock at the top of the tender Portal, will be valid for all actions of requesting bid submission, bid opening etc., in the e-Procurement portal. The Time followed in this portal is as per Indian Standard Time (IST) which is GMT+5:30. The bidders should adhere to this time during bid submission.
24. The bidders are requested to submit the bids through online e-Procurement system to the TIA well before the bid submission end date and time **(as per Server System Clock)**.
